(b) Make sure the NH Legislature draws the maps using a process that is completely open and accessible to the public at every step. Program Services: (1) Established best-practice objective criteria for creating fair district maps for NH; (2) Convened a group of experts and citizens (Mapathon group) that worked through 2021 and drew a complete set of fair maps (based on the criteria) to serve as a baseline fair-map standard; (3) Educated the public and the legislature on what constitutes fair maps by distributing the model maps, producing PSAs such as the weekly Open Democracy Minute for radio, and providing expert analysis on all proposed maps; (4) Activated regional groups to sponsor and pass Warrant Articles calling for fair maps at Town Meetings and then analyzing sure the maps proposed for their areas met the fair standard; (5) Tracked, monitored, and reported on the legislative process for drawing the district maps at every step of the way to open each step to the public. Accomplishments: 74 warrant articles passed, 12 PSAs and analyses provided to public media, and legislators, 221 regional group participants, 150 regional group meetings, 100+ fair-map activities carried out by regional groups.
