IN THE FIRST SIX MONTHS OF 2021, NORTH VALLEY FOOD BANK CONTINUED TO ADDRESSES HUNGER IN THE NORTHERN FLATHEAD. WE PROVIDED FOOD ASSISTANCE TO 350-500 PEOPLE WEEKLY THROUGH OUR LOCAL DISTRIBUTION IN WHITEFISH, OUR MOBILE PANTRIES IN NEIGHBORING COMMUNITIES AND OUR DELIVERIES TO SENIOR CITIZENS. WE SERVED A TOTAL OF 745 UNDUPLICATED HOUSEHOLDS WITH A TOTAL OF 1988 UNDUPLICATED INDIVIDUALS. ADDITIONALLY, WE FACILITATED A SUMMER MEALS PROGRAM SERVING AN ESTIMATED 20 FAMILIES DAILY AND SUPPORTED A TOTAL OF 166 HOUSEHOLDS WITH EMERGENCY RENTAL ASSISTANCE APPLICATIONS BETWEEN APRIL AND JUNE. IN 2020, WE EXPANDED OUR DISTRIBUTION HOURS FIVE-FOLD TO 14 HOURS A WEEK, ESTABLISHED FOUR BI-MONTHLY MOBILE PANTRIES IN SURROUNDING RURAL COMMUNITIES, DOUBLED OUR SENIOR DELIVERY PROGRAM TO SERVE 70 HOUSEHOLDS, AND PURCHASED A BOX TRUCK TO TRANSPORT FOOD TO SEVERAL FELLOW FOOD PANTRIES. THROUGH OUR DIRECT SERVICES WE PROVIDED OVER 500,000 POUNDS OF FOOD TO 30,498 INDIVIDUALS, MAKING UP 11,402 HOUSEHOLDS (4,445 UNIQUE INDIVIDUALS, 1,540 HOUSEHOLDS). MARCH 2020 COVID-19 EMERGENCY FUNDRAISER: DUE TO INCREASED DEMANDS DUE TO COVID-19, NORTH VALLEY FOOD BANK (NVFB) SENT OUT AN APPEAL FOR COVID-19 EMERGENCY FUNDS TO ADDRESS THE NEEDS OF THE COMMUNITY IN MARCH 2020. IN THE FOLLOWING TWO MONTHS, MORE THAN 130,000 WERE RAISED. THESE FUNDS SUPPORTED NVB'S EMERGENCY RESPONSE OPERATIONS, A COORDINATED PROJECT WITH LOCAL RESTAURANTS TO PROVIDE FRESH COOKED MEALS TO CUSTOMERS AND MULTIPLE MOBILE PANTRIES. OCTOBER 2020 FOOD DRIVE: IN OCTOBER, NVFB FIRST ANNUAL TRICK OR TREAT SO KIDS CAN EAT EVENT RAISED ALMOST 5,000 POUNDS OF FOOD AND MORE THAN 10,000 IN CASH.
