Land Conservation - GVLT furthered its mission to conserve working farms and ranches, wildlife habitat, and river corridors in the Gallatin Valley. We identify strategic areas with high conservation values and work to conserve blocks of open land that protect special parts of the valley. We hold 118 conservation easements covering 50,521 acres. Our staff develop long-term relationships with landowners and visit each conservation easement annually to monitor their condition and partner with landowners on restoration projects to improve eroding streambanks, plant vegetation, and enhance floodplains. In FY21 we conserved 1,522 acres of land in the Gooch Hill, Churchill, East Gallatin, Paradise Valley, and Madison River areas. We also continued our integrated conservation and recreation project model by purchasing a 18 acre property in Bear Canyon for potential future public access and habitat protection.

Community Trails - GVLTs Community Trails Program continued to connect people, communities, and the land through collaborative trail projects. In 30 years GVLT has helped create over 80 miles of trail. Our Trails staff worked with 32 volunteer groups to maintain community trails at Drinking Horse, Bozeman Pond, Triple Tree, Painted Hills, Highland Glen Nature Preserve, Gallagator Trail, Sourdough Trail, Kirk Hill, and Glen Lake Rotary Park. We partnered with other outdoor recreation groups to launch an Outside Kind campaign to share messages with the public about appropriate and considerate outdoor behavior.

Education GVLT shares monthly news with over 18,000 supporters on communitytrails, private land conservation, and related public events. GVLT publishes audited financial statements, IRS Form 990, and an annual report on the website. The 21 young professionals on the NextGen Advisory Board educate and inspire their peers to volunteer and support GVLT. We joined local land use planning efforts to highlight trail systems and natural resource protection. GVLT hosted 659 volunteers for 2,466 hours of service and educated them all on GVLTs mission and accomplishments. GVLT brought the trails to life with families through a partnership with Random Acts of Silliness on the Fairy Village. The Summer Trails Challenge engaged thousands of community members to explore the trails and log 77,500 miles of trail use in three weeks.
