IT CALLS FOR RESIDENTS TO BE TEMPORARILY REHOUSED IN PURPOSE-BUILT EXPEDITED HOUSING FACILITIES UNTIL THEIR NEW PERMANENT AFFORDABLE DWELLINGS ARE MADEAVAILABLE THROUGH THE RECLAIMING AND RENOVATION OF THEIR FORMER SLUMLORD BUILDINGS. THESE SLUMLORD PROPERTIES WOULD BE ACQUIRED THROUGH LEGAL ACTION. THESE SAME YOUTH EXPERIENCE DISCRIMINATION AND THREATS TO THEIR SAFETY IN CONVENTIONAL SHELTERS.
