We mobilize lawyers and advocates in large-scale pro bono programs and issue advocacy campaigns to ensure that all levels of governmentnational, state, and localprovide equal rights, equal opportunities, and equal justice under the law.

Project Corazon - We provided legal assistance to thousands of asylum seekers at the U.S. southern border and throughout the U.S., in particular through our full-time legal clinic on the ground in the Rio Grande Valley. We secured humanitarian parole for 1,789 asylum seekers, enabling them to gain entry into the U.S. to pursue their immigration claims. Additionally, we provided legal assistance in securing work authorization for hundreds of asylum seekers within the U.S. under our new work permit initiative.

Lawyers for Racial Justice - We partnered with more than 50 law firms and in-house legal teams to research, analyze, and publish findings regarding state-based policies creating racial disparities. In particular, we published our findings on two topics in 2021: the lack of regulatory protections for child farmworkers and racial inequity in paid time off on election day. With the help of hundreds of pro bono volunteers from our law firm partners, we advanced research on additional racial justice issues, including juvenile justice, the role of police in schools, sentencing for misdemeanor crimes, automatic expungement and disparate impact. In sum, in 2021, we mobilized more than 300 lawyers from 50 law firms to conduct 1,000+ hours of research and analysis.

Climate Change - In 2021, we trained 42 municipalities from 24 states on new renewable energy tools, each of which can remove at least 55,986 metric tons of CO2 emissions from the atmosphere.
