FIVE OF THE 16 WERE FOR YOUNG READERS, AND 12 WERE IN TRANSLATION. 10 OF THE 16 WERE PUBLISHED BY THE US FOR THE FIRST TIME, AND THE REMAINING 6 WERE NEW EDITIONS OF AN EXISTING WORK. AS OF THE END OF 2021, WE HAVE OVER 100 TITLES IN PRINT AND ELECTRONIC FORM, SOLD ACROSS THE COUNTRY AND INTERNATIONALLY VIA RETAIL BOOKSTORES, ON THE WEB, INCLUDING FROM OUR WEBSITE, AND BY OUR DISTRIBUTOR, PUBLISHERS GROUP WEST.
