BETWEEN THE TWO LOCATIONS, GENESIS PROVIDED A TOTAL OF 6,438 CHARITY MEDICAL, DENTAL, MENTAL HEALTH COUNSELING, COMMUNITY HEALTH CONSULTATIONS, MEDICATION ASSISTANCE, AND SPECIALTY CARE COORDINATION TO LOW-INCOME UNINSURED INDIVIDUALS AS AN EXPRESSION OF THE LOVE OF CHRIST. THE BREAKDOWN OF SERVICES IS MEDICAL, 1,722; DENTAL, 1,525; COUNSELING, 466; COMMUNITY HEALTH, 1,861; MEDICATION ASSISTANCE, 411; AND SPECIALTY COORDINATION, 453.
