Adaptive Sports at Mount Snow is a volunteer-driven non-profit that provides adaptive sports, recreational opportunities and educational experiences to the Mount Snow community and its visitors throughout the year. Adaptive Sports at Mount Snow helps individuals with disabilities to develop skills and instill pride and confidence that enables them to demonstrate their strengths and capabilities.

Adaptive Sports at Mount Snow (ASMS) served approximately 40 individuals and spent over 550 instructional hours providing adaptive ski and snowboard lessons to those with disabilities during the Winter 2020-21 season. Unfortunately, due to COVID-19 restrictions, the Organization was unable to serve any groups or school programs. In compliance with COVID restrictions, ASMS hosted numerous special programs virtually during the summer to serve and remain engaged with veterans groups, individuals with physical and intellectual disabilities, and specialized support networks. In the summer of 2020, ASMS ran a "Safe at Home" video series, along with several virtual challenges designed to encourage activity and keep the community engaged. Two in-person programs were run during the summer: the "Special Olympics Bluebirds Golf TeamX and the "Veterans Fly Fishing Retreat" which provided recreational activities to a total of 15 participants. We had approximately 60 volunteers who donated approximately a collective 1,000 volunteer hours.
