Community Wellness Camps- Camp Silah (110 kids (33% refugee, 33% immigrant, 33% non-refugee/immigrant) is a 4-day overnight camp focused on fostering friendship and community, integration and psychosocial support using trauma-informed modalities, and providing a safe place to share, engage, explore, and play. Camp Mahara (100 kids 100% immigrant and refugee) is a 3-day Skill- Building horse camp is grounded in service learning and the development of four critical skills (life, survival, social and coping) with an emphasis on project and time management, goal setting, embracing failure as part of success, family dynamics and understanding the difference between fun and joy. The camp also incorporates physical activity vital for emotional, social and mental health.

Covid Relief: Through our partnership with Oregon Health Authority, we were able to provide direct aid for families struggling due to covid related job loss. Help included rent and utility assistance as well as groceries and household supplies. We were able to provide assistance to 49 families in 2021.

Direct Assistance: PRSG provides emergency financial funds to families to assure they stay on a positive path along with financial assistance for driver's education, medical bills, and legal help. In 2021 we provided financial assistance to 122 families.
