We connect with vulnerable neighbors who are disabled, elderly, addicted and/or in recovery, low-income, and homeless or marginally housed. The City Hope Community Center offers dignified meals in a beautiful space, as well as free grocery deliveries to disabled elderly neighbors. The City Hope House is a two-year transitional program for residents in recovery, and the City Hope Caf opens every weekday as a welcoming coffeehouse for Tenderloin neighbors to connect with each other and local resources.
