To provide access to clean water for those in developing countries (ie. Malawi, Africa). This is accomplished by drilling new boreholes, repairing pumps and/or installing solar water systems.

LIWALA SCHOOL. Installed 10,000 ltr solar water system for school and surrounding community. Project includes a newly drilled borehole, double steel tank-stand fabrication, (2) 5,000 ltr water tanks, and installation of all solar components (pump, panels, cables, piping). Implemented construction of tap-stands throughout the school and surrounding communities. Running water can now be found at 12 taps, a handwashing station and 2 additional taps extended in the community. Prior to this, the community water source was so congested, people would line up to draw water as early as 2:00 am. 1,400 students served (+ surrounding community)

CHALAULA SCHOOL. Installed 5,000 ltr solar water system for a very remote primary school and surrounding village. Prior to receiving the water system, students and villagers collected water from unprotected hand-dug holes and or the local stream. The project includes a newly drilled borehole, fabrication of steel tank-stand, a 5,000 ltr water tank, installation of all solar components (pump, panels, cables, piping). Running water can now be found in 12 taps, including inside restrooms, handwashing station, school tap, teacher's housing tap and 1 tap extended into the community. There are no other clean water sources in the area other than this system. 262 students serves + 49 households in the village

4c (Code:) (Expenses \$ **17,014** including grants of \$ **0**) (Revenue \$ **0**)

NAMIKATE SCHOOL. Installed 10,000 ltr solar water system for school and surrounding community. This very large school did not have its own water source. The school shared a water source with the nearby village - a hand-dug well that was fitted with a handpump. Solar water system includes a newly drilled borehole, (2) 5,000 ltr water tanks, installation of all solar components (pump, panels, cables, piping, security fencing and barbwire) and implementation and construction of tap-stand. 1,157 students impacted + surrounding village

Direct project expenses. \$203,381 - This includes drilling, installation of solar pumps and panels, etc., and represents 95.3% of Other Program Service Expenses. \$10,090 was allocated for travel (4.7%). The remaining \$44 was for bank wire fees directly related to the projects.
