Sentinel Foundation provided rescue to Americans and their families that had no means to leave Afghanistan. This mission was to prevent human suffering and minimize displaced women and children from being trafficked while fleeing. This operation started in August 2021 and is ongoing.

Sentinel Foundation conducted counter child trafficking operations in various countries in Latin America.
