During the 2021 fiscal year, we served 374 referrals, all representing a survivor looking for housing and recovery services, and YTD, we have served a total of more than 700 referrals. NTSA formed a review panel and built an accreditation program to be launched in October 2021 specifically for long-term residential programs serving survivors of trafficking and sexual exploitation. NTSA's membership increased to over 90 members, all of which are organizations directly supporting survivors (or are in the start-up phase, working to serve survivors) and now have access to hundreds of resources to support their efforts via our member portal.
