In 2021, Families4Families (F4F) expanded tremendously. In the 2021 year, Families4Families collected and delivered over 250,000 meals, which amounts to nearly 4,000 families, or 16,000 individuals, served one week's worth of groceries. F4F volunteers collected a carefully curated grocery list we named A Bag of Basics. This list included an array of items such as fresh produce, dairy products, various sandwich meats, pasta, rice, cereals, and other foods that families can actually sustain themselves on. Beyond the robust groceries, F4F volunteers regularly included personalized notes and extra additions that were seasonally themed. This included, (but was not limited to), Valentines, winter jackets, hats, gloves, personal protective equipment, and Thanksgiving turkeys as well as pies. F4F is proud to say we were able to mobilize thousands of students across the country to address food insecurity in a hands-on, and thoughtful manner in 2021.

Families4Families pairs student-led clubs with carefully vetted nonprofit partners. The F4F Student Clubs collect groceries and other essential items and deliver them to their nonprofit partner. Their nonprofit partner identifies families in need in their community, and together, the students and nonprofit partners get the resources to those families. With the help of over 2,500 monthly volunteers, the F4F network delivers 20,000 meals to families every month as well as other essentials. This breaks down to 300 families, or 1,200 individuals, served monthly. To date, the Families4Families network has delivered 650,000 meals to families in need across the country. The Families4Families model has been replicated in 14 cities across the country, and one U.S. territory: Puerto Rico. The 2020-2021 year began with 15 F4F Student Clubs and ended with 23. Now, we have 34 F4F Student Clubs in the DMV, 15 national chapters. F4F is engaging students nationwide passionate about combatting food insecurity in their communities. With F4F, students nationwide are not only combating food insecurity, but they are creating meaningful relationships with community members they might otherwise never know. Students are learning in a hands-on fashion what inequities look like, but also, how they themselves can make a positive impact.
