FeLV vaccinations for all shelter felines who have tested FeLV negative. We have vaccinated over 80% of the shelter and continue to vaccinate all new intakes.

In 2021 with the help of our Staff Vet we removed all of the FIV+ (Feline Immunodeficiency Virus) from their own separate ward to relocate into our general population ward. We wanted to help reduce the stigma of adopting FIV+ kitties. We believe with the proper medical attention and environment FIV+ kitties can live just as long and healthy lives as non-positive felines.
