TO SAY THAT THE PAST YEAR WAS UNUSUAL FOR THE ORGANIZATION ("THE AVON") PROGRAMMATICALLY DUE TO A GLOBAL PANDEMIC IS A VAST UNDERSTATEMENT. THE AVON, AS A NON-PROFIT ARTS ORGANIZATION, EXISTS TO BRING PEOPLE TOGETHER TO BE INSPIRED, EDUCATED AND/OR ENTERTAINED BY HIGH QUALITY, MEANINGFUL FILMS AND COMPLEMENTARY PROGRAMS. TO DO THIS DURING A PERIOD WHEN PUBLIC GATHERINGS WERE DRAMATICALLY CURTAILED, AND THE RELEASE OF NEW FILMS WAS SIGNIFICANTLY REDUCED, CREATED HISTORIC CHALLENGES. DESPITE THE CHALLENGES, WE ARE BOTH PROUD AND CONFIDENT THAT THE AVON CONTINUED TO DELIVER ON ITS MISSION AND KEPT THE COMMUNITY ENGAGED.EARLY IN THE PANDEMIC, THE AVON CREATED "AVON ONLINE; A VIRTUAL CINEMA INTENDED TO BRING THE MAGIC OF QUALITY FILM TO THOSE WHO WERE FORCED TO SEEK INSPIRATION AT HOME. COLLABORATING WITH INDEPENDENT STUDIOS AND DISTRIBUTORS, WE OFFERED HUNDREDS OF NEW RELEASES, DOCUMENTARIES, AND FOREIGN LANGUAGE FILMS SUBSCRIBED TO BY OVER 1,000 PATRONS. WHILE WE DO NOT BELIEVE THAT THIS REPLACED THE GREAT VALUE OF SEEING THESE FILMS IN OUR BEAUTIFUL AND HISTORIC COMMUNITY SETTING, IT WAS A WELCOME AND NOBLE TEMPORARY SOLUTION. OUR STREAMING FILMS WERE SUPPLEMENTED WITH TWO VIRTUAL PROGRAMS: ONE A FASCINATING LIVE/ZOOM CONVERSATION REGARDING A DOCUMENTARY, AND THE SECOND, A PANEL DISCUSSION WITH EXPERTS FROM THE INDUSTRY ABOUT THE IMPACT OF THE PANDEMIC ON INDEPENDENT FILM. THESE BOTH ATTRACTED SIZABLE GROUPS OF ENGAGED PARTICIPANTS.THE AVON REOPENED MID-YEAR WITH A FULL SET OF SAFETY PROTOCOLS AND WORKED HARD TO DELIVER THE KIND OF CINEMATIC INSPIRATION THAT THE THEATRE IS RENOWNED FOR. THOUGH OUR TRADITIONAL PANEL DISCUSSIONS WERE NOT POSSIBLE, WE ASSEMBLED A GREAT MIX OF NEW RELEASES, FILMS FROM UP-AND-COMING FILMMAKERS, AND SPECIAL CLASSIC SERIES FEATURING SOME OF THE WORLD'S MOST CHERISHED FILMS INCLUDING CASABLANCA, CHINATOWN, PSYCHO, SINGING IN THE RAIN, AND A JAMES BOND RETROSPECTIVE. FOR THE HOLIDAYS, WE INVITED FAMILIES BACK TO THE AVON FOR A SPECIAL FIRST-TIME SCREENING OF THE NUTCRACKER PRESENTED BY THE BOLSHOI BALLET. THE AVON'S ANNUAL SCHOLARSHIP PROGRAM CONTINUED TO GROW WITH A RECORD NUMBER OF HIGH SCHOOL STUDENTS FROM THROUGHOUT THE REGION SUBMITTING ESSAYS ON WHY FILM MATTERS. THERE WERE MANY STRONG ENTRIES TO THE PROGRAM; SO MANY, THAT THE AVON WENT OUT IN SEARCH OF ADDITIONAL DONATIONS IN ORDER TO DISTRIBUTE \$9,000 IN SCHOLARSHIPS. THIS WAS AN INCREASE OF ALMOST 30% IN A VERY CHALLENGING FISCAL YEAR.DESPITE THE CHALLENGES POSED BY THE DIFFICULT YEAR, THE AVON CONTINUED TO PRIORITIZE COLLABORATION WITH OTHER LOCAL ORGANIZATIONS, WITH A MAJOR HIGHLIGHT BEING THE SCREENING OF "TRACES OF THE TRADE", A DOCUMENTARY FOCUSED ON A FAMILY THAT COMES TOGETHER FOR A JOURNEY TO LEARN ABOUT AND COME TO TERMS WITH ITS UNFORTUNATE LEGACY IN THE SLAVE TRADE. THIS WAS DONE IN PARTNERSHIP WITH A LOCAL PRESBYTERIAN CHURCH.
