THE CAMP WAS A VIRTUAL CAMP THIS YEAR RELATED TO COVID-19 AND THE PEDIATRIC CARDIOLOGISTS OF OREGON RECOMMENDING THAT WE HAVE A VIRTUAL CAMP FOR THIS YEAR. WE HAD 20 CAMPER, AGES 9 TO 15, WITH HEART CONDITIONS RANGING FROM COMPLEX CONGENITAL HEART SURGERY, PACEMAKERS FOR ARRHYTHMIA PROBLEMS AND PULMONARY HYPERTENSION WHO ATTENDED THE VIRTUAL CAMP. OUR COUNSELOR IN IN TRAINING PROGRAM CONSISTED OF 2 YOUTH WHO AGED OUT OF CAMP AND ALL THESE YOUTH HAVE A HEART CONDITION. WE HAD 10 VOLUNTEERS WHO ASSISTED DURING THE VIRTUAL CAMP. THE FORMAT FOR THE VIRTUAL CAMP FOLLOWED THE SUCCESSFUL SCHEDULE OF MERRY HEART CAMP 2020, WITH 3 HOURS OF VIRTUAL CAMP IN THE MORNING. WHILE ONLINE, CAMPERS WERE DIVIDED INTO "CABINS" OF 5-7 WITH A COUNSELOR-IN-TRAINING AND A COUNSELOR, AND THE WHOLE CAMP POPULATION SPENT TIME TOGETHER, AS WELL. EACH CHILD RECEIVED A CAMP-IN-A-BOX FILLED WITH AN ACTIVITY BOOK, MATERIALS FOR THE ACTIVITIES, THEIR CAMP T-SHIRT, AND MANY OTHER FUN CAMP ITEMS. COUNSELORS-IN-TRAINING DEMONSTRATED THE CRAFTS IN THE MORNING ONLINE AND, THE CAMPERS MADE THEIR OWN ACTIVITY IN THE AFTERNOON AND DEMONSTRATED THEIR RESULTS TO THEIR CABIN MATES THE NEXT DAY.
