LEGAL AID PROVIDES CIVIL LEGAL SERVICES TO THE POOR IN AREAS SUCH AS DOMESTIC VIOLENCE, HOUSING, INCOME MAINTENANCE AND CONSUMER-RELATED ISSUES. THE FOCUS IS ON THE BARRIERS LOW-INCOME OREGONIANS FACE IN ACCESSING CIVIL LEGAL AID.
