Create CA advocates for high quality arts education for all California students. Create CA is in its fifth decade of working to build a brighter future for our state by making the arts a core part of every child's quality education. A statewide leader and convener, Create CA galvanizes California's abundance of arts and culture experts to advocate for quality arts education for all students. By collaborating effectively with the state's leading education and parent engagement agencies, and providing an anchor for policy expertise at the state and local levels, Create CA is the leader in promoting the arts in schools and enriching the lives of children, families, and communities.

	Create CA is pleased to present a report on our major program accomplishments and highlights. During fiscal year 2021, Create CA (Create), now merged with the California Alliance for Arts Education (Alliance), made significant strides toward increasing equitable access to quality arts education for all PK-12 students in California. Create's Arts Now Communities program supported 39 local coalitions of arts education advocates and over 550 advocates attended the annual Arts Now Leadership Institute. We also convened 40 partner organizations through our statewide Policy Council to mobilize their networks in support of arts education and educational equity. During fiscal year 2021, the former Alliance and Create CA explored and approved a strategic merger. The Alliance had been Create CA's long-time partner and fiscal sponsor. On July 1, 2021, we merged and now formally operate under the Create CA name and brand. Both organizations shared goals and values, organizational DNA, and respect among stakeholders and a merger was mutually beneficial for several reasons. First, pooled resources, aligned work and speaking with one clear voice makes the merged organization more viable, effective, and strategic. Secondly, combining Create CA's Arts Education Data Project and Public Will Campaign with the Alliance's policy and advocacy work amplifies our collective impact. Finally, state and local policy issues are better prioritized where roles and systems are clarified through one merged governance structure. The merger allows us to deepen the impact of our work towards advancing systems change in the field of arts education. Arts Now Communities Over the last year, Create CA hosted 19 virtual advocacy trainings and professional learning opportunities. A total of 855 individuals attended these free events and received tools and resources from Create. Below is a summary that includes highlights from several of the events we hosted: Create CA worked with P.S. ARTS and researcher Dr. Rekha Rajan to disseminate findings from a two-year study examining the relationship between social emotional learning and participation in inclusive arts programs among students with disabilities and without disabilities. We hosted a Special Education and the Arts webinar on February 10, 2021, which presented case studies from the research study and discussed how special education programs have responded to the challenges and opportunities presented by distance learning during COVID-19. In collaboration with Arts for LA, Create CA hosted "Advocating for Student Health & the Arts: Getting the Arts into Your District's LCAP" on March 17, 2021. This webinar provided a brief overview of the Local Control & Accountability Plan (LCAP) process and document, presented the compelling argument for including the arts in the LCAP as a key strategy to support student health and shared the experience of a district administrator who successfully worked to include arts education in the LCAP to support social emotional learning. On May 5, 2021, Create CA hosted an interactive webinar that (re)contextualized the lived experience of many Indigenous students in the North-West Region of California public schools today. The webinar centered the voices of Hupa, Karuk and Yurok Indigenous artists and educators working to understand and meet the needs of students by employing culturally sensitive, trauma-informed and arts-based practices. Participants engaged in personal reflection and group discussion designed to advance their skills as an ally to and advocate for Indigenous students. The Arts Now Leadership Institute was an opportunity for Arts Now Leaders to connect with fellow advocates, learn about the support Create CA offers and leave equipped with the tools they need to advocate for high-quality arts education in their district. Arts Now Leaders and their local partners attended the following events in FY21: "October 8, 2020: School Board Presentation Workshop" October 14, 2020: Importance of Local Advocacy in School Board Races" October 22, 2020: Rural Arts Education Strategies" November 19, 2020: Student Voices Campaign Launch Event" September 1, 2021: Arts Now Community Welcome " September 9, 2021: Introduction to Grassroots Organizing " September 16, 2021: Digital Strategy and Public Will Building " September 23, 2021: Building an Equitable, Inclusive Coalition " September 29, 2021: Action Planning Working Session In the past, gathering stakeholders at in-person events has been a significant strategy of the Arts Now Communities program and our Policy Council. Since the COVID-19 pandemic has prevented in-person gatherings, we have transitioned all of our events to a virtual format. We have found that this shift has allowed us to reach new audiences, to provide additional accessibility accommodations such as ASL interpretation and to pilot new mentoring strategies for our Arts Now Leaders. We have learned a lot during the transition to all virtual programming and continue to explore new technologies that allow for audience engagement in a virtual setting. We anticipate continuing to explore hybrid (virtual and in-person) strategies as California recovers from the COVID-19 pandemic and reopens. Student Voices Campaign The Student Voices Campaign was featured at the GRID Summit 2020. The GRID is a three-day digital festival celebrating creativity. The virtual, live-streamed summit gave students ages 13-18 an opportunity to explore their creative interests and passions. Through workshops, industry spotlights and performances, the GRID provided a pathway to personal transformation and career preparation for young people by expanding their understanding of why creativity is essential for the future job market and particularly relevant to the high-tech and creative economies. As a result of the partnership with the GRID, we saw an increase in participation, with 181 students submitting to the Student Voices Campaign annual art competition. On April 16, 2021, Create CA hosted an event called "GRID: Student Voice" which celebrated the winners of the annual Student Voices Campaign. Students had the opportunity to spend the day hearing from a panel of industry professionals and taking workshops with Nickelodeon, EditMentor, Girls Make Beats, and Sparc. Speakers included student changemakers from GENup, Project Knucklehead, and The Art Hour. There were also networking opportunities for students to connect with their peer advocates from around the state. In September 2021, Create CA launched a new pilot youth engagement program called the Arts Education Activism Internship, which brings together 9th-12th grade students from across California to explore the impacts of activism. In this online program, students work creatively and collaboratively to build a statewide network of student activists committed to creating change in their schools and communities. Participants gain skills and strategies for navigating education systems and career pathways through mentorship cohorts and guest speakers as well as the opportunity to engage with creative industry professionals who are advocates for positive change in their fields. The program involves a presentation to school board members in the student's district and the planning and execution of an awards celebration for outstanding submissions to the Student Voices Campaign. Policy Council On January 28, 2021, Create CA hosted a virtual Policy Council meeting during which the 40 member organizations and guests gathered to hear an update about the dance and theatre credential from Dr. Eric Engdahl and the state budget picture from Assemblymember Patrick O'Donnell (70th District - Long Beach). In addition, members discussed Create CA's local advocacy strategy and learned details of the Alliance and Create CA's strategic restructuring exploration. The meeting provided an invaluable opportunity for arts education leaders to come together, share updates from the field and organize around the most pressing issues in the state. On June 24, 2021, Policy Council members and guests gathered virtually to hear a state budget and legislative update from Create CA's legislative advocate, Kathy Lynch. The majority of the meeting was spent completing an interactive landscape analysis and mapping of opportunities for the 2021-2022 school year. Members spent time in breakout groups sharing the work of their organizations and discussing plans for the coming school year.

Create CA's mission was to ensure all students are able to reach their full potential by advancing an education model that promotes creativity and the arts for the workforce of tomorrow. On July 1, 2021, the fiscal sponsored organization ceased existence. The fiscal sponsor, formally known as California Alliance for Arts Education, changed their name to Create CA.
