These grants are critical to help local efforts to regain control of and sustainably manage traditional territories. Climate Action Fund grants support frontline communities directly challenging the damage caused by the fossil fuel industry. PPP Loan Forgiveness	During May 2020, RAN received \$770,000 in a forgivable loan under the Small Business Administration Paycheck Protection Program (PPP). Congress established the PPP to provide relief to small businesses during the coronavirus pandemic as part of the \$2 trillion Coronavirus Aid, Relief, and Economic Security (CARES) Act, P.L. 116-136. This legislation authorized the United States Treasury Department to use the SBAs 7(a) small business lending program to fund loans of up to \$10 million per borrower that qualifying entities can spend to cover payroll, interest, rent, and utilities. In December 2020, RAN applied for and received full forgiveness of the PPP loan and recorded the full amount of \$770,000 as gain on extinguishment of debt on the statement of activities in the audited financial statements. In the tax return, this amount is shown as an other increase in net assets on Form 990 page 12.
