North America Program Alaska -Worked with an Alaska-based coalition of Tribes, fishermen, business owners and organizations on the conservation of Bristol Bay watersheds. Oregon -Partnering with more than a dozen conservation and fishing organizations, WSC led a process to modernize forest management and the conservation of salmon habitat on state and private lands. Washington -On the Olympic Peninsula, WSC worked with local Tribes, land owners, agencies and conservation partners on culvert replacement efforts and other salmon habitat restoration projects.
