We work at the forefront of climate equity and resilience initiatives to improve the quality of indoor and outdoor air, increase clean transportation options and access to other clean technologies, and support communities of color to prepare for and respond to challenges posed by climate change.

We work to build the capacity of local leadership to advance community-driven and equitable solutions to ensure their demands are prioritized by activists and policymakers at every level of government.

We hold financial institutions and the public sector accountable to meet the financial needs of communities of color, and help ensure that low income communities and people of color are not left out of new wealth-building opportunities with the transition to a digital economy.
