PLANT COLLECTIONS, PROPAGATION AND GARDEN SUPPORT - SAN FRANCISCO BOTANICAL GARDEN SOCIETY (SFBGS) FUNDS GARDEN IMPROVEMENTS AND PROVIDES CURATORIAL AND PLANT COLLECTIONS MANAGEMENT SERVICES. AS OF JUNE 30, 2021, THERE WERE 12,176 ACCESSIONS IN THE GARDEN'S LIVING COLLECTIONS, COMPRISED OF 7,774 DIFFERENT KINDS OF PLANTS, 11% OF WHICH ARE OF WILD COLLECTED ORIGIN. PROGRAM SERVICE REVENUE INCLUDES PLANT SALES AND THE PREVIOUS YEAR SAW MORE THAN 7,587 PLANTS SOLD TO THE COMMUNITY.

BETWEEN JULY 1, 2020 AND JUNE 30, 2021, SFBGS HOSTED 6,441 CHILDREN INTERACTING WITH NATURE THROUGH SCHOOL-YEAR, SUMMER AND FAMILY PROGRAMS.
