Training and consultation is provided by seasoned entrepreneurs, professional business coaches, and guest speakers with expertise in finance, sales, accounting, and other disciplines. Workshops are co-sponsored by corporations, banks, community organizations, and other entities, like the SBA, that have a shared interest in increasing the financial literacy, business acumen, and scale of disadvantaged businesses. Training content includes: accounting; digital marketing; certification; loan readiness; contract readiness; and a variety of other topics aimed at helping owners to grow their businesses, earn higher profits, and hire more local employees.
