AFIDEP'S PRIMARY MANDATE IS TO PROMOTE APPLICATION OF RESEARCH EVIDENCE IN THE FORMULATION OF DEVELOPMENT PUBLIC POLICIES IN AFRICA. AFIDEP'S CHARITABLE PURPOSE IS TO CONTRIBUTE TO SUSTAINABLE DEVELOPMENT IN AFRICA BY ENABLING THE FORMULATION OF POLICIES AND PROGRAM INTERVENTIONS THAT ARE INFORMED BY SOUND RESEARCH EVIDENCE.
