DURING THE REMAINDER OF THE YEAR THE INSTITUTE HOSTED 25 RETREATS AND EVENTS WITH MANY SPIRITUAL MASTER TEACHERS WHO WORK IS FOCUSED ON EXPLORING THE INTERSECTION OF PERSONAL AND SOCIAL TRANSFORMATION. THE INSTITUTE HOSTED SEVERAL THOUSAND ATTENDEES TO ATTEND MOSTLY LARGER AND LONGER OFFERINGS.
