PRESERVATION CHICAGO HAS BEEN DEEPLY ENGAGED WITH MANY OF THESE LONG-TERM EFFORTS AND OUR LEADERSHIP AND INVOLVEMENT WITH THESE ADVOCACY EFFORTS PROVED DECISIVE. AFTER SO MANY YEARS OF EFFORT, TO FINALLY SEE THESE BUILDINGS IN A SAFE PLACE IS BOTH WONDERFULLY EXHILARATING AND PROVIDES A PROFOUND SENSE OF RELIEF. BONIFACE CHURCH RESIDENTIAL CONVERSION UNDER CONSTRUCTION (21 YEAR EFFORT), EPWORTH CHURCH RESCUED FROM DEMOLITION (4 YEAR EFFORT), LAKE STREET SCHLITZ BREWERY TIED HOUSE/LA LUCE RESCUED DEMOLITION (7 YEAR EFFORT), IIT MAIN BUILDING ADAPTIVE REUSE APPROVED (8 YEAR EFFORT), GREATER UNION BAPTIST CHURCH PRELIMINARILY LANDMARKED (7 YEAR EFFORT), SETH WARNER HOUSE LANDMARKED (4 YEAR EFFORT), EMMETT TILL & MAMIE TILL-MOBLEY HOME LANDMARKED AND TO BE RESTORED AS MUSEUM (7 YEAR EFFORT), CLARENDON PARK COMMUNITY CENTER RENOVATION BROKE GROUND (8 YEAR EFFORT), CHICAGO & NORTH WESTERN RAILWAY HEADQUARTERS BUILDING LANDMARKED AND RESTORED (4 YEAR EFFORT), AND MANY MORE.INCREASED STAFF CAPACITY HAS YIELDED AN INCREASE IN MISSION-DRIVEN ACTIVITIES.
