THE PROJECTS FOCUS ON ANALYZING ECONOMIC AND INDUSTRY TRENDS, PERFORMING COLLABORATIVE RESEARCH PROJECTS AND FORMING OPINIONS ON AUTOMOTIVE RELATED POLICIES. DESPITE THE PANDEMIC, CAR RESEARCHERS COMPLETED 22 RESEARCH PROJECTS, OF WHICH 2 WERE FEDERALLY FUNDED. THEY ALSO HAVE 9 PROJECTS THAT CARRY OVER TO 2021, OF WHICH 7 ARE FEDERALLY FUNDED.
