Community Advised, Designated Grants and Donor Advised Funds bring donors, grassroots organizers and funders together for grantmaking and community building, strengthening relationships across sectors of the social justice movements. PDF regards Fiscal Sponsorships as a natural extension of our mission and program, and we work with on average NU fiscally sponsored groups. With offices in California and Massachusetts, we are able to offer fiscal sponsorship to groups across the US and those based in the US and working internationally. 128 total grants were made.
