EDITOR BRUCE MOHL RELEASED A REPORT ON A LONG-FORGOTTEN TAX CAP THAT WAS NEARLY OVERLOOKED WHEN TAX REVENUES HIT RECORD HIGHS. THE REPORTING ULTIMATELY LED TO \$2.94 BILLION IN TAX REFUNDS TO MASSACHUSETTS RESIDENTS AND FORCED CRITICAL PIECES OF LEGISLATION TO BE RENEGOTIATED IN LIGHT OF REVISED REVENUES. MASSINC ALSO PARTICIPATED IN A COALITION OF ELECTED OFFICIALS, POLICYMAKERS, DEVELOPERS, AND RESIDENTS IN SUPPORT OF THE EXPANSION OF THE HOUSING DEVELOPMENT INCENTIVE PROGRAM.
