CIRI IS COLLABORATING WITH LOCAL CONNECTICUT ORGANIZATIONS TO ENSURE THAT THE ASSISTANCE WAS PROVIDED TO THE APPROPRIATE RECIPIENTS. IN COLLABORATION WITH SOCIAL SERVICE AGENCIES, LEGAL SERVICES, AND LAW ENFORCEMENT, THE PROGRAM HELPS SURVIVORS GAIN ACCESS TO PUBLIC BENEFITS, THERAPY, SAFE HOUSING AND THE MEDICAL CARE THEY NEED TO REBUILD THEIR LIVES. PROJECT RESCUE PROVIDES STATEWIDE TRAINING TO SERVICE PROVIDERS AND LAW ENFORCEMENT ON VICTIM IDENTIFICATION AND OUTREACH TO INCREASE PUBLIC AWARENESS. THE PROGRAM ALSO COLLABORATED WITH STATE AND NATIONAL NETWORKS TO SECURE SAFETY AND RESETTLING OF UNACCOMPANIED MINORS IN SHELTER AND AS THEY MOVE FROM SHELTER TO THEIR SPONSORS/FAMILY MEMBERS.SURVIVOR SERVICES: THE PROGRAM IS DESIGNED TO PROVIDE ELIGIBLE INDIVIDUALS WITH SPECIALIZED SERVICES TO ADDRESS THE COMPLEX RESULTS OF HUMAN RIGHTS ABUSE.
