NCACs activities are dedicated to protecting the right to free speech and access to information by: Assisting students, teachers, librarians, parents and others opposing censorship in schools and libraries Helping artists, curators and museum directors resist art censorship Informing public officials, the media and the general public about First Amendment rights and obligations Advocating for public policies and laws that respect First Amendment rights and principles Educating young people and the wider public about the importance of free expression, claiming their rights and respecting the rights of others Engaging with a nationwide network of activists and supporting local activism Analyzing censorship trends, publishing analysis and developing new strategies to promote free speech rightsAs part of Core Program, NCAC is an alliance of 59 national non-profit organizations, including literary, artistic, religious, educational, professional, labor, and civil liberties groups. For nearly 50 years, we have engaged in direct advocacy and education to support First Amendment principles. NCAC is unique in that we are national in scope but often local in our approach. We work with community organizations and members to resolve censorship controversies without litigation.NCAC sponsors the Free Expression Network (FEN), a group of more than 50 organizations that work on free expression issues. During Zoom meetings that occur every other month, FEN members share information and strategy about new issues. The FEN listserv facilitates efforts to collaborate on advocacy letters, joint statements and amicus briefs.Every year NCAC receives hundreds of requests for assistance from teachers, librarians, artists, the media, researchers, students, and others. It provides a wealth of resources through its website as well as private counseling. NCAC is committed to providing all concerned citizens with the tools they need to defend their rights.

4b (Code:) (Expenses \$ 262,823 including grants of \$) (Revenue \$)

The Youth Free Expression Program (YFEP) is dedicated to the education of young people, helping them assert and defend their right to free expression. Any attempt to restrict the creative and intellectual freedom of young people is harmful. The program works with students, teachers, parents, school administrators, and community members to oppose removal of books from school libraries and classrooms, censorship of student-created visual art, efforts to silence student journalists, cancellation of student-led plays and musicals, restrictions on student speech on social media, and efforts to censor health, history, and science curricula.YFEP took decisive action in 2022 to tackle the critical issue of book banning in U.S. schools and libraries. The American Library Association reported a record number of attempts to ban books in 2022, affecting 2,571 titles. The office meticulously recorded instances of censorship in its Youth Free Expression Database, which provides NCAC.org visitors with a comprehensive picture of book banning and challenges across the nation. Additionally, through its Kids' Right to Read Project (KRRP), NCAC delivered a record number of letters to school boards that were considering book bans or violating their policies for adjudicating book challenges. It also works directly with students, parents and other community members who were fighting censorship.In 2022, YFEP launched a new project, Student Advocates for Speech, to help high school students fight for their free speech rights as well as the rights of others, including those they disagree with. It assists participants in starting clubs in their schools, and provides training about free speech principles with authors, journalists and other experts, helping them educate other students, participate in media interviews and write op-eds.

4c (Code:) (Expenses \$ 175,880 including grants of \$) (Revenue \$)

The Arts and Culture Advocacy Program (ACAP) helps artists and curators involved in censorship disputes. Our goal is to resolve controversies and develop strategic educational initiatives that equip artists and institutions with the necessary tools to promote artistic freedom. NCAC is the only free speech organization with a program dedicated to the rights of artists. In 2022, there were many attacks on artwork online in schools and community spaces. Artists using social media face challenges from content moderation policies that often fail to consider the artistic context of posts. This has led to content removal, account suspension, and other restrictive measures. In 2022, ACAP participated in the launch of Don't Delete Art (DDA), a collaboration with several international arts and free expression organizations. DDA defends artistic freedom online and is working to convince social media companies to change their policies.ACAP manages Censorpedia, an online wiki of censorship incidents from the Iron Age to the 21st century, and Artist Rights, an online archive of legal cases affecting artists as well as resources describing their rights.
