Normally, we also operate a homeless shelter with 15 beds for men providing shelter from November through mid-April. Because of Covid we did not run our Shelter Program in 2022. We provide bag lunches at noon and a hot meal once a week. We support the Borgne Foundation. The Borgne Foundation in Haiti is a Catholic worker house which provides nourishment and educational opportunities to between 50 and 75 impoverished children and elderly/disabled adults. This program is also supported through contributions.
