THE MISSION IS TO ADVANCE CHILDREN'S LITERACY SKILLS USING AN ENGAGING CURRICULUM, CERTIFIED DOGS, AND DEDICATED VOLUNTEERS. DURING 2021-22, SITSTAYREAD'S 19TH YEAR, WITH THE HELP OF 75 HUMAN AND 25 CANINE VOLUNTEERS, SITSTAY READ SERVED 1,847 STUDENTS IN 116 CLASSROOMS ACROSS 18 CHICAGO PUBLIC SCHOOLS USING THREE DIFFERENT REMOTE LEARNING PROGRAMS DEVELOPED FOR STUDENTS IN KINDERGARTEN THROUGH THIRD GRADE. IN ADDITION TO THE REMOTE LEARNING CURRICULUM, SITSTAYREAD PROVIDED MORE THAN 20,000 BOOKS TO STUDENTS DURING THEIR PANDEMIC LEARNING YEAR.
