IF A MORE ADVANTAGEOUS TRANSACTION OR ARRANGEMENT IS NOT REASONABLY POSSIBLE UNDER CIRCUMSTANCES NOT PRODUCING A CONFLICT OF INTEREST, THE BOARD OR NOMINATING & CORPORATE GOVERNANCE COMMITTEE SHALL DETERMINE, BY A MAJORITY VOTE OF THE DISINTERESTED DIRECTORS, WHETHER THE TRANSACTION OR ARRANGEMENT IS IN IBRA'S BEST INTEREST, FOR ITS OWN BENEFIT, AND WHETHER IT IS FAIR AND REASONABLE. IN CONFORMITY WITH THE ABOVE DETERMINATION, IT SHALL MAKE ITS DECISION AS TO WHETHER TO ENTER INTO THE TRANSACTION OR ARRANGEMENT. THE NOMINATING & CORPORATE GOVERNANCE COMMITTEE SHALL INTERPRET AND OVERSEE THE IMPLEMENTATION OF THE CONFLICTS OF INTEREST POLICY, REVIEW AND SUGGEST MODIFICATIONS TO IMPROVE THE CONFLICTS OF INTEREST POLICY.
