Critical Resistance seeks to build an international movement to end the prison industrial complex (PIC) by challenging the belief that caging and controlling people makes us safe. We believe that basic necessities such as food, shelter, and freedom are what really make our communities secure. As such, our work is part of global struggles against inequality and powerlessness. The success of the movement requires that it reflect communities most affected by the PIC. Because we seek to abolish the PIC, we cannot support any work that extends its life or scope.

National Work: Strategic Communications activities have included: Wrote and distributed press releases; organized and facilitated spokesperson trainings; organized a media training series; distributed written communication to CR's national email list; interviewed with national radio and press; organized and participated in digital events and webinars; consistent social media communication; published and distributed report on pre-trial reforms nationally. Produced and distributed The Abolitionist, a bilingual newspaper written by imprisoned people and non-imprisoned people, sent to over 6,500 imprisoned people, and nearly 150 non-imprisoned people. Leadership Development activities have included: Conducted capacity trainings and workshops with our staff and members in areas including campaign planning and implementation, base building, fundraising, media advocacy and organizational development; provided trainings, workshops, and presentations for community members and organizations across the country; Hired and trained three new staff members (in the areas of Communications and Administration). Organizational Development activities have included: Created a new organizational national strategic plan for 2021-2022; coordinated national grassroots fundraising activities; organized large and small in-person and digital events and webinars; migrated donor contacts to a contact management system; held annual fundraiser over a digital platform in tandem with our Oakland chapter.

Leadership Development activities have included: Conducted capacity trainings and workshops with our Oakland members in areas including regionally specific coalition and campaign planning and implementation (Close CA Prisons), base building, fundraising, media advocacy and organizational development; provided trainings, workshops, and presentations for community members and organizations across the Bay Area. Organizational Development activities have included: Ongoing implementation of the CR Oakland chapter's annual workplan; held a retreat for CR Oakland development; coordinated regional grassroots fundraising activities; organized in-person and digital events; held monthly Freedom Fridays events; facilitated network of volunteers to support with prisoner correspondence. Grassroots Organizing activities have included: Implemented our campaign work through: public educational events; produced educational and organizing materials; held mobilizations aimed at building broad-based community member engagement and grassroots support; organized actions to build public pressure; developed and presented workshops about our campaigns. Maintained some support for a San Francisco based coalition and an Alameda County based coalition both working to address harms of their respective counties jail systems; continued to participate heavily in a statewide coalition to address prison closures in California.
