WE BELIEVE THAT STRATEGIC AND INCLUSIVE GOVERNANCE OF THE MINING SECTOR IS CRUCIAL IN AVOIDING DAMAGE TO CITIZENS AND COMMUNITIES. WE HIGHLIGHTED RISKS AND OPPORTUNITIES OF LITHIUM PRODUCTION IN MEXICO AND ALSO SUPPORTED ROBUST LEGAL AND POLICY FRAMEWORKS FOR MINERAL GOVERNANCE IN UGANDA.

WE ALSO BELIEVE THAT INCLUSIVE AND WELL-RESOURCED PUBLIC PROCESSES ARE CRUCIAL IN ACCELERATING JUST TRANSITIONS IN ENERGY AND ECONOMIC SYSTEMS. IN NIGERIA, WE SUPPORTED A SUSTAINABLE ECONOMIC FUTURE BEYOND OIL. IN COLOMBIA, WE RESPONDED TO POLITICAL OPENINGS TO SUPPORT A JUST ENERGY TRANSITION. WE SHINED A LIGHT ON NATIONAL OIL COMPANIES THROUGH AN EXTENSIVE GLOBAL DATABASE AND LINKING DATA TO INFORM OUR WORK ON CLIMATE CHANGE. ADDITIONALLY, WE BUILT CAPACITY ON ENERGY TRANSITION RISKS FOR OVER 500 STAKEHOLDERS FROM OIL AND GAS EXPORTING COUNTRIES AROUND THE WORLD. WE BOLSTERED GRASSROOTS CIVIL SOCIETY IN A REGIONAL MINING BASIN IN TUNISIA THAT LED TO CITIZEN PARTICIPATION IN GOVERNANCE REFORM PROCESSES AND INCREASE IN CONSTRUCTIVE DIALOGUE.
