APPROXIMATELY 3,000 BOXES WERE DISTRIBUTED TO CLIENTS OF OUR OUTREACH CENTER. THE CAF BREAD ROOM ALSO PROVIDES BREAD AND BACKED GOODS DAILY FOR CLIENTS TO TAKE AS THEY LEAVE THE CENTER.
