The Executive Director is also the mother of the two owners of Worcester Resources Worcester Wreath and recuses herself from being in the room or discussing anything regarding the RFP or its execution. During the most recent RFP process Wreaths Across America also contracted with an outside organization to oversee and administer the Request for Proposal process.
