The core services include the operation of a confidential, 24-hour hotline for survivors of sexual violence and their significant others; sexual violence survivor accompaniments to police precincts, courts, and hospital emergency departments to help survivors through the evidence collection process; sexual violence prevention education programming at schools, colleges, and community-based organizations; outreach events to raise awareness among the Essex County communities and counseling / support groups for sexual violence survivor and their significant other All services are free of charge.

Family Service Leagues Counseling Program provides professional counseling services to individuals, couples, and families.
