THIS UNIQUE AND CHARMING COMEDY ABOUT TWO NYC SANITATION WORKERS HONORED THE ESSENTIAL WORKERS WHO HAD KEPT OUR CITIES FUNCTIONING DURING THE DARKEST DAYS OF THE COVID-19 PANDEMIC, AND PTC'S COMMUNITY ENGAGEMENT EFFORTS INCLUDED HOSTING SANITATION WORKERS AND THEIR FAMILIES AT THE THEATRE FOR A FREE PERFORMANCE.
