EACH YEAR, BASED ON THE PERFORMANCE OF THE COMMONWEALTH FOUNDATION DURING THE PRIOR YEAR, THE BOARD DETERMINES A LEVEL OF SALARY INCREASE THAT IS EITHER BASED ON ANNUAL, NATIONAL OR REGIONAL DATA OR, IF AN INCREASE SIGNIFICANTLY DIFFERENT FROM DATA IS PROPOSED, THE BOARD CONDUCTS A SALARY REVIEW OF SIMILAR POSITIONS OF ORGANIZATIONS SIMILAR TO THE FOUNDATION AND THE SALARY IS ADJUSTED ACCORDINGLY BASED ON THOSE FINDINGS. THIS REVIEW IS CONDUCTED BY BOTH CONTACTING SEVERAL ORGANIZATIONS DIRECTLY FOR SALARY DATA AND BY COMPARING OTHER PUBLICLY AVAILABLE SALARY INFORMATION, SUCH AS PUBLICLY AVAILABLE FORM 990 TAX RETURNS.
