THESE INITIATIVES INCLUDE PROGRAMS AND PROFESSIONAL DEVELOPMENT OPPORTUNITIES THAT TRAIN STUDENTS AND PROFESSIONALS ON THE CONNECTIONS BETWEEN BEHAVIORAL SCIENCES, HEALTH EDUCATION, HEALTH PROMOTION AND THE ENVIRONMENT. SOPHE'S PARTNERSHIP WITH THE NATIONAL COMMISSION FOR HEALTH EDUCATION CREDENTIALING (NCHEC) CONTINUES WITH COLLABORATIVE WEBINARS TO EXPLORE CAREERS IN HEALTH EDUCATION.
