Advocacy Pro-Choice Washington conducts lobbying trainings for our activists to help them impact the decisions of their legislators and elected officials. With these tools, activists might take direct action - emailing, calling, or 11 meetings with lawmakers - or use personal platforms to bring awareness to an issue. During the Washington State Legislative Session, Pro-Choice Washington mobilizes trained activists to lobby their lawmakers on behalf of the Pro-Choice Washington legislative agenda to advance reproductive freedom, health equity, and community wellbeing across the State.

Education Accountability Pro-Choice Washington coordinates phone calls, social network engagement, and lawmaker outreach, with Pro-Choice Washington organizing staff in support of endorsed candidates. Once candidates are elected, Pro-Choice Washington works with these leaders at the state and municipal level to pass laws and policies that expand and protect access to abortion and reproductive care for all people in Washington.
