THE ORGANIZATION BELIEVES WOMEN CAN SHATTER THE CHAINS OF ADDICTION AND HOPELESSNESS WHEN SURROUNDED BY WHAT MEANS THE MOST TO THEM - THEIR CHILDREN.SOJOURNER HOUSE IS PROUD TO BE ONE OF THE ONLY PROGRAMS IN ALLEGHENY COUNTY THAT PROVIDES EACH FAMILY WITH THEIR OWN APARTMENT WHILE THE MOTHER RECEIVES TREATMENT.
