Community Organizing: WRAP members identify issues of concern to homeless people through street outreach. WRAP member groups then work for change on the issues identified. In 2021, WRAP members focused on some of the laws that criminalize people attempting to survive unhoused. Our member groups continue to join together in an effort to stop this criminalization. WRAP convened 24 member meetings and 1 face-to-face member gathering.

Public Education: WRAP members engaged in public education through speaking at community meetings, writing op-eds, and presenting at conferences and universities. WRAP also created 15 new pieces of art work, published 20 newsletters. WRAP also created, printed, and shipped 1500 WRAP t-shirts to member groups.
