THE ORGANIZATION OPERATES A KINDERGARTEN CLASS IN ZOROKORO. THE CHILDREN BENEFIT FROM TUTORING SESSIONS AND OTHER EXTRACURRICULAR ACTIVITIES IN THE FORM OF ADDITIONAL INSTRUCTIONS IN MATH, COMPUTER SCIENCE, CODING, FRENCH, ENGLISH, PHYSICAL TRAINING, AND DANCE CLASSES. THE CHILDREN ARE PROVIDED WITH VOCATIONAL TRAINING IN TAILORING, BARBERING, HAIR BRAIDING, MOTORBIKE MECHANICS, AND CARPENTRY.
