THEY FIND SOLACE, PROTECTION AND COMPANIONSHIP THROUGH THEIR PETS. THEY CARE FOR THEIR PETS ON LIMITED RESOURCES SO THEY THEMSELVES HAVE LESS. OUR TASK, NATIONWIDE, IS TO FEED AND PROVIDE BASIC EMERGENCY VETERINARY CARE TO THEIR PETS AND THUS RELIEVE THE ANGUISH AND ANXIETY OF THE HOMELESS WHO CANNOT PROVIDE FOR THEIR PETS.

PET FOOD AND SUPPLIES: NON-CASH AWARDS OF PET FOOD (136,576.93 LBS) AND PET SUPPLIES WERE DISTRIBUTED TO NON-PROFIT ORGANIZATIONS (PRIMARILY FOOD BANKS) ACROSS THE COUNTRY TO ASSIST WITH THE FEEDING OF PETS BELONGING TO THE HOMELESS AND DISADVANTAGED. PET FOOD AND SUPPLIES THAT WERE PURCHASED BY THE ORGANIZATION WERE GIVEN TO THE NON-PROFITS. SLEEPING CRATES WERE SHIPPED DIRECTLY TO NON-PROFIT HOMELESS SHELTERS.

EMERGENCY VETERINARY CARE: IN 2022, THERE WERE 1,986 INVOICES TOTALING \$1,121,695 (AVERAGE OF \$565) PAID TO 618 HOSPITALS IN 46 STATES WITH A TOTAL OF 1,379 PETS TREATED; 84% WERE DOGS, 15% WERE CATS AND 1% WERE OTHER PETS OF THE HOMELESS. SOME HOSPITALS GAVE A DISCOUNT. 61% OF THE CALLERS WERE WOMEN AND 10% WERE VETERANS. THE AVERAGE TIME THEY HAD BEEN HOMELESS WAS 3 YEARS AND 1 MONTH. 26% WERE LIVING IN THEIR VEHICLES.

WELLNESS CLINICS: A TOTAL OF 6 HOSPITALS/CLINICS OF NON-PROFITS PERFORMED WELLNESS CLINICS IN THREE STATES TO A TOTAL OF 297 PETS. 4 OF THE HOSPITALS RECEIVED AN AWARD AND 2 OF THE HOSPITALS PERFORMED THE WELLNESS CLINICS WITHOUT AWARDS. WELLNESS CLINICS INCLUDE BASIC EXAMS AND VACCINATIONS. SOMETIMES SPAY/NEUTER PROCEDURES ARE PERFORMED AT THE LOCATION OF THE CLINIC.
