THE TOTAL NUMBER OF PEOPLE TRAINED IN 2022 WAS 7,079, REACHING 26 COLORADO COUNTIES. OUR PRIMARY AUDIENCES INCLUDED HEALTH CARE AND CHILD WELFARE WORKERS, AS WELL AS LAW ENFORCEMENT.
