We envision a just world in which we each belong, prosper, and thrive in the place we now call home, no matter where we came from. Welcoming America offers an approach to demographic shifts that bends toward equity and justice rather than inequality and nativist policies. Grounded in the leadership of communities, we connect, support, and amplify those leading the work of addressing the systemic disparities and discrimination encountered by immigrants, advancing a strong foundation of welcoming in local communities. Our work includes growing and connecting the movement of leaders working to foster inclusive communities, building a growing network of local government and nonprofit members working nationwide, supporting thousands of leaders through training, tools, and expertise on building welcoming communities, and strengthening ties among neighbors across lines of difference. With the launch of our most recent strategic plan, Welcoming America is working to certify diverse archetypal places as welcoming, demonstrating measurable progress in building public and multisector infrastructure for immigrant equity at the local level; create a bigger and more organized field of practice that positions communities to achieve the Welcoming Standard; and create access points for new champions to offer their time, resources, and voices.
